



## Extraordinary Announcement of 4iG Plc.

the acquisition of an additional 19.5% shareholding in Vodafone Magyarország Zrt., and the divestment of the shareholding in Yettel-CETIN.

4iG Public Limited Company ("4iG") hereby informs the participants of the capital market that today, its subsidiary "ANTENNA HUNGÁRIA" Magyar Műsorszóró és Rádióhírközlési Zártkörűen Működő Részvénytársaság (registered seat: 1119 Budapest, Petzvál József u. 31-33; company registration number 01-10-042190) ("Antenna Hungária") had acquired from Corvinus Nemzetközi Befektetési Zártkörűen Működő Részvénytársaság (registered seat: 1024 Budapest, Fény utca 16 2nd floor; company registration number: 01-10-043547) ("Corvinus") 35,476,749 ordinary shares of series A, with a nominal value of HUF 500 each, representing 19.5 percent of the share capital of Vodafone Magyarország Távközlési Zártkörűen Működő Részvénytársaság (registered seat: 1112 Budapest, Boldizsár utca 2, registration number: 01-10-044159) ("Vodafone Hungary"), through a share swap. The transaction increased Antenna Hungaria's direct controlling stake in Vodafone Hungary to 70.5 percent. With the swap transaction, Corvinus, and thus the Hungarian state indirectly acquired the 250-250 shares of TMT Hungary B.V. (registered office: Strawinskylaan 933, 1077 XX Amsterdam, The Netherlands; company registration number: 70498288) and of TMT Hungary Infra B.V. (registered office: Strawinskylaan 933, 1077 XX Amsterdam, The Netherlands; company registration number: 81357397) representing 25% of the Hungarian subsidiaries of PPF Telecom Group (Yettel Magyarország Zártkörűen Működő Részvénytársaság (registered seat: 2045 Törökbálint, Pannon út 1; company registration number: 13-10-040409) and Yettel Real Estate Hungary Zártkörűen Működő Részvénytársaság (registered seat: 2045 Törökbálint, Pannon út 1; company registration number: 13-10-041060) furthermore CETIN Hungary Zártkörűen Működő Részvénytársaság (registered seat: 2045 Törökbálint, Pannónia út 1; company registration number: 13-10-042052) (hereinafter jointly: "Yettel-CETIN"). As a result of the swap, Antenna Hungária was replaced by Corvinus as the indirect owner of the Hungarian companies of Yettel-CETIN and the stake of Corvinus in Vodafone Hungary was reduced to 29.5%.

Following the registration of the changes in ownership structure, the Board of Vodafone Hungary is to be expanded from the current five to seven, with members of five from Antenna Hungária and two from Corvinus. The composition of the Supervisory Board remains unchanged. The state's prerogatives in the governing bodies will also remain unchanged.

Customers of Vodafone and Yettel will not be affected by the change in the ownership structure, and both residential and business customers will continue to benefit from the services of the companies.
