



**Extraordinary Announcement of 4iG Plc.
on implementing a Transformation Program**

4iG Public Limited Company ("4iG") hereby informs the participants of the capital market that the Transformation Programme ("Programme") launched on 13 November 2023 has reached its next significant milestone with the decision of the founder ANTENNA HUNGÁRIA" Hungarian Broadcasting and Radio Telecommunications Private Company Limited by Shares (in Hungarian: "ANTENNA HUNGÁRIA" Magyar Műsorszóró és Rádióhírközlési Zártkörűen Működő Részvénytársaság) – of which 4iG is the qualified majority owner – to split the broadcasting business of AH Media Commercial Closed Company Limited by Shares (in Hungarian: AH Média Kereskedelmi Zártkörűen Működő Részvénytársaság; "AH Media") and the broadcasting business of AH Infrastructure Services Closed Company Limited by Shares (in Hungarian: AH Infrastruktúra Szolgáltató Zártkörűen Működő Részvénytársaság "AH Infra") by way of a spin-off by merger, so that the broadcasting business of AH Media and AH Infra will be merged into AH NÉGY Limited Liability Company (in Hungarian: AH NÉGY Korlátolt Felelősségű Társaság; "AH Négy").

At this stage of the Programme, there is therefore a concentration of business sectors as a result of a complex legal process. AH Négy is launched as 4iG Broadcasting Infrastructure Limited Liability Company on the market. The date of the spin-off by merger has been set by AH as 28 February 2025, with the first day of operation under the new structure being 1 March 2025.

4iG will continue to keep investors informed about the Programme and its implementation status, in line with its previous practice.
